






Last Word On Georgia Laws

Who do you think should have the final say on laws passed here in Georgia?




Georgia Supreme Court Selection

PERSON 1: Supreme Court Justices should be elected by voters because elections hold Justices accountable for their decisions and rulings.


PERSON 2: Supreme Court Justices should not be elected by voters because elections put pressure on Justices to make certain decisions and rulings based on public opinion.



Party ID Disclosure for State Supreme Court Candidates



Which of the following will be MOST important to you in deciding how to vote for Georgia State Supreme Court in November?




Role of Personal Viewpoints

I am going to read you the opinions of two people. Please tell me which one comes closest to your view.


PERSON 1: Judges should interpret and apply the law as it is written and not take into account their own viewpoints and experiences.



Attitudes Towards Judicial Activism


"Judicial activism" is the term used to describe when a judge bases a decision on his or her own personal views instead of the law like the State Constitution or statute.

How much do you think the Justices on the Georgia State Supreme Court engage in judicial activism?







Attitudes Toward Judicial Restraint


